Depending on the specific type of additional coverage purchased by the Sender, in the event of loss of or damage to the contents of the Parcel, the indemnity paid by the Operator shall be equal to the amount specifically provided for under said additional coverage. In addition to the sums paid by virtue of such additional coverage, the Operator shall also reimburse the price paid for the Services not correctly performed.

In the event that the Sender does not purchase any additional coverage, the amount of the indemnity paid by the Operator for the loss of or damage to the Parcel shall be equal to the amount set forth in Article 12 of the Terms and Conditions of the InPost Direct Service in force on the date of shipment. This indemnity shall be accompanied by the reimbursement of the price already paid by the Sender for the Service.

Irrespective of whether the aforementioned additional coverage is purchased, the user retains the right to assert, including in judicial proceedings, their right to compensation for damages pursuant to and for the purposes of Art. 1696 of the Civil Code and Art. 11 of the Terms and Conditions of the InPost Direct Service. The indemnities referred to above must be deducted from the amount of such compensation for damages, if already paid by InPost. In particular, such compensation for damages may exceed the indemnity generally provided for in the absence of additional coverage, provided it is demonstrated that the loss of or damage to the parcel is attributable to InPost due to willful misconduct or gross negligence.
